ORDER:-

The Director of Centre for Innovations in Public Systems, Hyderabad in the reference 1st read above has desired for exploring the possibility of institutionalizing the Vision Centres in the Primary Health Centres (PHCs) in Telangana State with technical and Managerial assistance from Aarvind Eye Care, Madurai or L.V. Prasad Eye Institute, Hyderabad.

2. In the reference 2nd read above, the Director of Public Health, Hyderabad. has stated that the equipment as prescribed by the Government of India will be procured and supplied to the Vision Care Centers from National Rural Health Mission Funds as approved in the PIP 2014-15.

3. Government after careful examination of the matter, hereby sanction an amount of Rs. 28,00,000/- (Rupees Twenty Eight Lakhs only) (@ Rs.7,00,000/- each for four centers) for one time expenditure for procurement of Equipments and the recurring expenditure @ Rs. 2,00,000/- (Rupees Two Lakhs only) per annum from the NRHM Funds. The centres will be operated by PHC under technical and managerial assistance from L.V. Prasad Eye Institute, Hyderabad.

4. The Director of Public Health, Telangana State / the Commissioner of Health & Family Welfare, Telangana State, Hyderabad / the Mission Director National Rural Health Mission, Telangana State, Hyderabad shall take necessary action in the matter.
